

Will of David Harrison Purley

In the Name of God Amen.

I David Harrison Purley of Morgan County Indiana being of sound mind and disposing memory and in order to make certain disposition of my property hereby revoking all former wills by me made do hereby make and publish this my last will and testament.

Item 1 I will and bequeath to each of my children John Purley Sarah Jane Boyd and Rebecca Thornberry the sum of one hundred dollars to be deducted out of their promisory notes which I now hold against them.

Item 2^d I will and bequeath to my son Andrew J Purley the sum of one hundred dollars to be deducted out of his promisory note which I now hold against him for one hundred and forty three dollars and seventy five cents.

Item 3. I will and bequeath to my daughter Martha Bass the sum of One hundred dollars to be deducted out of her promisory note which I now hold against her for two hundred and thirty five dollars.

Item 4. I will and bequeath to my son David H Turley the sum of One hundred dollars after deducting the amount due me on his promisory note for thirty five dollars and also deducting eighteen dollars advanced by me to him for taxes.

Item 5. I will and bequeath to each of my grand children Lou Neese and Harrison Neese the sum of fifty dollars the said share of Lou to be paid to her when she marries and the said share of Harrison to be paid when he becomes of the age of twenty one years.

Item 6. I will and bequeath to my daughter Leon C. Paddock the sum of one hundred dollars after deducting the amount due me from her on her promisory note which I now hold against her for thirty two dollars and ninety five cents.

Item 7. I will and bequeath to each of my daughters Leora Jackson Kate Turley and Rose

Gurley the sum of one hundred dollars.

Item 8 To my beloved wife Susan V Gurley I will and bequeath after the payment of my just debts and funeral expenses all the residue of my personal estate of every kind and description whatsoever to her and her heirs forever.

Item 9 to my beloved wife Susan V Gurley I will and devise the farm upon which I now reside in Madison Township Morgan County Indiana more particularly described as follows.

Part of the South East quarter of section thirty five (35) Township fourteen (14) Range two east containing one hundred and thirty six and one half acres more or less. for the term of five years and at the expiration of said five years said land to be equally divided among all my children and their representatives saving to my wife all her rights under the law as my widow. to them and their heirs forever.

Item 10th I hereby nominate and appoint my beloved wife Susan V Purley as my executrix of this my last will and testament.
